## **Conditions of Participation**

This International Contemporary Art Exhibition, open to the public from **4 July to 26 September 2021**, will be held in several spaces and monuments of Ponte de Lima. Visit the menu '**Map 2021**' to get to know them!

**Participation:** national and international artists can apply, with a maximum of three artworks, in the scope of the theme of the 2020 edition '*Paths of Spirituality: Culture, History and Heritage*'.

**Submissions:** Submissions are made online, in the option 'Artist Area', **until 11 April 2021**.

**Participation Areas:** Architecture, Artist Book, Ceramics, Computer Art, Drawing, Illustration, Installation Art, Land Art, Painting, Photography, Poetry, Projection Art, Sculpture, Sound Sculpture, Video.

**Artist Area:** This area is for the participants. In it, SUBMISSIONS are made, the SUBMISSION RESULTS are published, as well as the DELIVERY ADDRESS for sending the selected artworks, data for the INSURANCE and the CATALOGUE are given by the artist, the movement of the artworks is checked, from RECEPTION to RETURN. The artist should register and then visit the area regularly and follow his/her personal area in the platform ART'IN LIMA 2021.

**Confirmation of reception of artwork(s):** All Artists are informed, through his/her 'Artist Area', if the artwork was SELECTED or NOT SELECTED. The artists with selected artworks

should confirm their participation and the availability of the artworks, by email, to [curadoria@artinlima.com](mailto:curadoria@artinlima.com) and [geral@artinlima.com](mailto:geral@artinlima.com).

**Address for reception of artworks:** The selected artists will be informed until **30 April**, through the Artist Area, of the address for delivery and exhibition of his/her artwork(s) in the village of Ponte Lima.

- Artists should fill in, print and sign the **Form Reception of Artworks**, available in the 'Artist Area' and upload the filled in document in the personal area, before reception of the artwork in Ponte de Lima, or send in with the artwork(s) when send or delivering it/them at the exhibition venue.

**Insurance:** All artworks sent to the art exhibition will covered by insurance from the moment of reception to the return of the artwork(s).

**Sending/Reception of artworks:** Artists are responsible for sending the selected artworks, to the given address in his/her 'Artist Area'. The sending and reception period of selected artworks is from **10th May until 4 June 2021**.

- Artworks with glass protection are not accepted.
- Selected Artists should fill in the Form Insurance and upload, in PDF format, in his/her 'Artist Area', **until 10 May 2021**.
- Participants out of EU should get information on the customs procedures for sending their artworks.

**Montage:** All the special conditions, of montage and exhibition, should be described in detail in the submission. Any specific installation requirement (e.g. light,...) should be asked for and wait for confirmation. Artists can make the installation of their artworks in Ponte de Lima, by arranging dates with the organizing committee.

**Catalogue:** Each participating artist with selected artworks will receive a catalogue of the exhibition.

- For the catalogue, blurred pictures of the artworks, or artworks with elements besides the artwork, or those which are too small or taken with a mobile, are not accepted. The resolution of the picture is 300 dpi and the size 2.5 MB the maximum, in JPG or PNG format.
- Selected Artists should fill in the **Form Catalogue** and deposit, in WORD format, in his/her 'Artist Area', **until 2 May 2021**. If this is not sent, the artist will not be included in the catalogue and this offer will be cancelled.

**Inauguration:** To be held on the **3th July 2021**. Visit our webpage and keep informed. We are counting on your presence in Ponte de Lima!

**Return of artworks:** Artists are responsible for collecting the artworks, at the exhibition venue or through a transport agency. The artworks can be collected **from 18 October until 19 November 2021**, by the artist, or by a representative, or by a transport agency. Artworks which are not collected until a month and a half after the end of the exhibition will be considered abandoned and become property of the Municipality of Ponte de Lima.

- Artists should fill in, print and sign the **Form Return of Artworks**, available in the 'Artist Area' and upload the document in his/her personal area, **until 19 September 2021**.
